4. HOW WE COLLECT YOUR PERSONAL INFORMATION

7. RETENTION OF YOUR PERSONAL INFORMATION

- 8.2 Confirmation of whether we hold personal information about you may be requested free of charge. If you would like to obtain a copy of your personal information held by the Efficient Group, please follow the procedure included in our PAIA manual.
- 8.3 You have the right to request the correction of personal information that we hold about you.

 The procedure to request the correction of your personal information is included in our PAIA manual.
- Please ensure that the personal information that we hold about you is complete, accurate and up to date. If you fail to keep your information updated, or if your information is incorrect, the Efficient Group may limit its services to you or elect not to proceed with a business relationship with you.
- 8.5 You have the right, in certain circumstances, to request the destruction or deletion of your

 - 9.1.1 the lawful processing of your personal information;
 - 9.1.2 any unintentional processing of your personal information; and/or
 - 9.1.3 the provision of incorrect or incomplete personal information to Efficient Group.

10. AMENDMENTS TO THIS POLICY

- 10.1 We may amend this policy from time to time for any of the following reasons:
 - 10.1.1 to provide for the introduction of new systems, methods of operation, products, services, offerings or facilities;
 - 10.1.2 to comply with changes to any applicable legislation;
 - 10.1.3 to ensure that our policy is clearer and more favourable to you;
 - 10.1.4 to rectify any mistake that may be discovered from time to time; and/or
 - 10.1.5 go any other reason which Efficient Group, in its sole discretion, may deem reasonable or necessary.
 - 10.2 Any such amendment will come into effect and become part of any agreement you have with the Efficient Group when notice is given to you of the change by publication on our website (www.efgroup.co.za). It is your responsibility to check the website frequently.

11. COMPLAINTS

Should you believe that Efficient Group has used your personal information contrary to applicable legislation, you undertake to first attempt to resolve any concerns with Efficient Group.
